Tim Carmody called the meeting to order.

Tim Carmody stated the proceedings are being recorded and reminded Council members that they are to abstain from participating in and/or voting on any action items involving a potential conflict of interest.

The first item (#1*) on the agenda was the disclosure of potential conflicts of interest on the Open Session agenda.

Tim Carmody asked if there were any conflicts of interest with any Council members on the Open Session agenda. There were none. Council agreed to move the Chapter 3 discussion to the end of the meeting, after voting on items from the Closed Session.

Motion carried 11-0. (It should be noted that Vicky Long-Hill voted "NAY" for closure on cases 15-024R and 17-015R)

Tim Carmody entertained a motion. Dave Lorenzen made a motion to Administratively Close case 17-006R. Jim Steinkuehler seconded the motion. There was no further discussion. A voice vote was taken. Tiffany Creekmur-Aye, Diane Venenga-Recuse, Ric Martinez-Aye; Melissa Henderson-Recuse, Elizabeth Quinn-Aye, Jim Steinkuehler-Aye, Tim Carmody-Aye, Dave Lorenzen-Aye, Vicky Long-Hill-Aye, Chad Leonard-Aye, Gene Beinke-Aye. Motion carried 9AYE, 2-Recusals.

Tim Carmody entertained a motion. Jim Steinkuehler made a motion to give case 18-010R back to ILEA staff for further investigation. Melissa Henderson seconded the motion. There was no further discussion. A voice vote was taken. Tiffany Creekmur-Aye, Diane Venenga-Recuse, Ric Martinez-Aye; Melissa Henderson-Aye, Elizabeth Quinn-Aye, Jim Steinkuehler-Aye, Tim Carmody-Aye, Dave Lorenzen-Aye, Vicky Long-Hill-Aye, Chad Leonard-Aye, Gene Beinke-Aye. Motion carried 10AYE, 1-Recusal.

Tim Carmody entertained a motion. Diane Venenga made a motion to give case 20-022 back to ILEA staff for further investigation. Ric Martinez seconded the motion. There was no further discussion. A voice vote was taken. Tiffany Creekmur-Aye, Diane Venenga-Aye, Ric Martinez-Aye; Melissa Henderson-Aye, Elizabeth Quinn-Aye, Jim Steinkuehler-Aye, Tim Carmody-Aye, Dave Lorenzen-Aye, Vicky Long-Hill-Aye, Chad Leonard-Aye, Gene Beinke-Aye. Motion carried 11-0.

The last item discussed in Open Session was in regards to Chapter 3 and the one-year time period in which an officer must become certified may be extended up to 365 days to allow for a postpartum recovery period. A brief discussion was had and the Council agreed to have further conversations at the next Council meeting in April 2022.
