Effective upon approval by Academy Council for February 2, 2023- June 30, 2023.

Law Enforcement Basic Academy Tuition and Fees

ILEA Basic Academy (Long course: 620 hours minimum)	\$6,650
ILEA Basic Academy (Short course: 400 hours minimum)	\$4,256
Regional basic training schools administrative fee	\$125/student
Registered Officer does not attend Basic Academy	\$125

The total cost of the Basic Academy Long Course at ILEA is \$9,975.00. The total cost of the Basic Academy Short Course at ILEA is \$6,384.00. As prescribed by Iowa Code 80B.11B, the Academy shall charge one-third of the total cost to the candidate (\$3,325.00/\$2,128.00) and one-third of the total cost to the agency or the department (\$3,325.00/\$2,128.00); except for the department of natural resources and the department of transportation, which shall incur the total cost; and for tribal government candidates, which shall incur the total cost.

In the event a recruit attends any part of the Basic Academy and, for any reason, cannot complete the class, tuition will be billed according to the following schedule:

Attendance through part or all of Week 1	\$125 Administrative Fee	Plus 20% of Total Basic Tuition
Attendance through part or all of Week 2	\$125 Administrative Fee	Plus 40% of Total Basic Tuition
Attendance through part or all of Week 3	\$125 Administrative Fee	Plus 60% of Total Basic Tuition
Attendance through part or all of Week 4	\$125 Administrative Fee	Plus 80% of Total Basic Tuition
Attendance through part or all of more Weeks 5-16		100% of Total Basic Tuition

In the event a recruit is injured or becomes ill, and is unable to complete the Basic Academy, fees may be adjusted on a pro-rated basis. If payment for the recruit has already been received by the Academy, an appropriate credit may be issued to the department.
