



ILEA Instructor Lane Thayer recently attended the Rangemaster Tactical Conference in Carrollton, Texas. Lane bested 198 other participants in the Pistol Match to win the "High Lawman" award. We understand ongoing training is serious business, and we're proud to share Lane's skillset.

**** PLEASE READ:** In order to adhere to Iowa rules, ILEA will become strict in our verification that all minimum hiring standards have been met **PRECEDENT TO ENROLLMENT** in any certifying training program, to include ILEA. These minimum hiring standards include reporting of; the background check, physical fitness testing, cognitive testing, psychological testing, hearing, vision and a medical exam.

As Pursuant to <u>501 3.1(1)</u> All law enforcement officers must be certified through the successful completion of training at an approved law enforcement training facility in order to remain eligible for employment. <u>As a condition precedent to enrollment</u> in a certifying training program, the Iowa law enforcement academy must be provided with verification by the enrollee's hiring agency that the minimum standard for Iowa law enforcement ment officers.

In recent months it has come to light that recruits are sometimes starting class with minimum hiring standards still pending verification. This violates lowa rules and will not be allowed. We understand that it may take an academy cycle to meet this expectation, but beyond that timeframe this is the expectation. Inability to meet this expectation could affect a recruit's enrollment in an academy, employment eligibility and cause an unnecessary expense.

Your assistance is appreciated in this manner.
