



HIRING STEPS

for

IOWA LAW ENFORCEMENT OFFICERS

A LAW ENFORCEMENT OFFICER who is **NOT** CERTIFIED in IOWA **OR** IN ANY OTHER STATE will follow these steps:

1. Complete LEO Report of Hire Form located [here](#)
 - a. A physical fitness test is required. For information please click [here](#)
 - b. A POST* is required. For questions on the POST test, please contact Donna Hallstrom at donna.hallstrom@iowa.gov
 - c. An MMPI** is required. For questions on the MMPI test, please contact Donna Hallstrom at donna.hallstrom@iowa.gov
 - d. A complete background check including fingerprints is required.
2. Complete the Minimum Medical Requirement Form located [here](#)
 - a. The uncorrected vision must be 20/100 or better to meet the minimum medical requirements

The MMPI and Minimum Medical Requirement Form can be uploaded electronically to the LEO Report of Hire.

A LAW ENFORCEMENT OFFICER who is CURRENTLY CERTIFIED IN THE STATE OF IOWA will follow these steps:

1. Complete the LEO Report of Hire Form located [here](#)
 - a. A physical fitness test is not required by ILEA.
 - i. You may enter "ILEA Certified" into this field
 - b. A POST is not required by ILEA
 - i. You may enter "ILEA Certified" into this field
 - c. An MMPI** is required or an MMPI transfer request can be submitted if a MMPI is valid within the past 12 months. That form is located [here](#). For questions on the MMPI test, please contact Donna Hallstrom at donna.hallstrom@iowa.gov
 - d. A complete background check including fingerprints is required.
2. A Minimum Medical Requirement Form is required only if the officer has had a break in law enforcement of over 180 days. That form is located [here](#)
 - a. The uncorrected vision must be 20/100 or better to meet the minimum medical requirements
3. If the officer has been out of law enforcement 6 months or longer they are required to get caught up on in-service training hours as out-lined in [Iowa Code 501, Chapter 8.4\(1\)](#)

The MMPI and Minimum Medical Requirement Form can be uploaded electronically to the LEO Report of Hire.

POST TEST SCORES:

* POST test scores shall be valid for a period of 12 months from the date of the examination. An applicant who has not been hired or placed upon a civil service certified list within 12 months of taking this test must retake and successfully pass the examination before being hired.

CIVIL SERVICE CERTIFIED LIST:

*Any applicant who has not been hired or placed upon a civil service certified list within the first 12 months of taking the MMPI-2 test must retake the examination and, before the applicant is hired, the results of the examination must be considered by the hiring authority. (MMPI refers to MMPI-2, MMPI2RF and MMPI-3)
