## \*\*IMPORTANT - PLEASE READ\*\*

501 - Chapter 2: Minimum Standards for LEO's & 501-Chapter 3: Certification of LEO's

501—2.1(80B) General requirements for law enforcement officers. In no case shall any person hereafter be selected or appointed as a law enforcement officer unless the person meets the minimum requirements.

In adherence to Iowa Administrative Rules **501—2.1(80B)** and **501—3.1(1)(80B)** regarding minimum standards and certification of Law Enforcement Officers, ILEA will continue to become more strict in our verification that all minimum hiring standards have been met **PRECEDENT TO ENROLLMENT** in any certifying training program, to include ILEA Basic Academy. A quick and easy reference for hiring steps can be found on the ILEA website under the Forms tab or here: Hiring Steps

Pursuant to 501—3.2(80B), Status forms are required to be provided to ILEA within 10 days for:

- \* Any hiring of personnel
- \* Change of status of existing personnel (promotions, name change, full-time/part-time)
- \* Any termination of employment of a law enforcement officer or termination of appointment as a reserve peace officer; including retirement, resignation in lieu of termination, disability

Prompt notification to ILEA of a new hire gives our staff time to verify all required documentation has been received. Delayed notification to ILEA of a new hire puts your agency and your new employee at risk of missing an available path to certification. As conveyed in the April newsletter, recruits beginning a path to certification with minimum hiring standards still pending verification violates lowa rules and will not be allowed. Inability to meet this expectation could affect a recruit's enrollment in an academy, employment eligibility and cause unnecessary expenses.

Beginning date for the next ILEA Basic Academy is **January 3, 2024.** Your attention to these matters is greatly appreciated.

## **UPCOMING SCHOOLS**

## DRUG DIVERSION TRAINING

**ILEA is partnering with the Iowa Dept. of Inspections and Appeals** to offer a Specialty School around drug diversions in nursing homes. Whether it be in a large city or a small town, theft of prescription medication by a nursing home employee from a vulnerable nursing home resident can and does occur anywhere.

**Drug Diversion in Long-Term Care Facilities** provides training in responding to and conducting thorough criminal investigations involving allegations of drug diversion within a nursing home. Drug diversion is the theft of prescription medications belonging to residents living in nursing homes committed by nursing home employees.

This training is intended for sworn law enforcement officers, but may also benefit prosecutors and regulatory investigators. Training format consists of interactive instructor-led discussion and practical scenarios. Course topics include, but are not limited to; dependent adult abuse pursuant to Iowa Code 235E, pertinent aspects of the healthcare industry, conducting drug diversion investigations, and charging applicable Iowa Code section.
